

**UNOFFICIAL REPORT OF MAJOR ACTIONS
COMMISSION FOR CONTINUING EDUCATION PROVIDER RECOGNITION
SEPTEMBER 26-27, 2024**

The Commission for Continuing Education Provider Recognition (CCEPR) met on September 26-27, 2024 at ADA Headquarters in Chicago. The following is a summary of matters considered by the Commission and actions taken. The Commission:

1. Considered 13 new applications for ADA CERP recognition, 57 applications for continued recognition, 9 progress reports, and two substantive change reports. The Commission granted initial recognition to 10 providers of continuing dental education, and continued recognition to 57 providers. The Commission withdrew recognition from three providers for failure to fulfill program requirements. The Commission also discontinued recognition of seven providers at the request of those providers. The Commission also considered a complaint against a provider. As a result of the Commission's actions, 487 CE providers will be ADA CERP recognized effective November 1, 2024. This total includes 45 providers approved through Joint Accreditation for Interprofessional Continuing Education.
2. Adopted a comprehensive revision of the ADA CERP Recognition Standards and four new ADA CERP policies; the revised Standards and new policies will take effect June 1, 2026.
3. Reviewed a progress report on the Commission's strategic plan and received a report on Commission finances through August 2024.
4. Considered a response to Resolution 410 which was submitted to the 2024 ADA House of Delegates.
5. Received information on the appointment to the Commission of three new members to the Commission, filling vacancies by members completing their terms; the new members, whose 4-year terms will begin in October 2024 are: Dr. Megan Cloidt, selected by the American Association of Public Health Dentistry; Dr. Andrew McDonald, selected by the American Dental Association; and Dr. Julie Robinson-Smith, selected by the American Academy of Oral Medicine.
6. Elected Dr. Marc Nuger as chair of the Commission for 2024-2025, and Dr. Jasbir Upadhyaya as vice-chair of the Commission for 2024-2025.
7. Acknowledged the following Commissioners whose terms will expire in October 2024: Dr. Kecia Leary (Chair), Dr. Kumar Patel, and Dr. Seena Patel.
